
## OVERSIGHT PROJECT IT'S YOUR GOVERNMENT

**WASHINGTON, DC** - Today, The Oversight Project and the Heritage Foundation secured a hard fought legal victory for transparency with the release of the official and authentic audio recording of President Joe Biden's interview with Special Counsel Robert Hur. For over a year, The Oversight Project has led the charge in federal court to procure the release of the Biden-Hur audio recording. The Justice Department has told the court that there are actually two recordings of President Biden's Interview with Special Counsel Hur. The Oversight Project received one recording and is actively fighting for the other one.

The Oversight Project is releasing the official audio obtained through litigation following the publication of a leaked audio by the left-wing publication, *Axios* on Friday, May 16. As The Oversight Project pointed out in an <u>emergency court filing</u> in the early morning of May 17, the original clips posted by *Axios* were edited and *did not match the official transcript previously released* to The Oversight Project in our lawsuit:



Mike Howell, President of The Oversight Project offered the following statement:

"Joe Biden should have never been in the White House. He was completely mentally unfit for the office. Everyone in the entire world knew this open secret and the result was a complete embarrassment to our proud Nation's constitutional Republic and system of government. The People are supposed to elect the Executive that they entrust with awesome powers.

Instead, through a highly questionable election fraught with serious defects, they instead received a conspiracy to give power away to unknown and unelected elites. The media and Biden Administration embarrassed themselves trying to deceive the public about Biden's health. The illegal withholding of this audio tape was election interference meant to protect a failing Biden and then Harris campaign. While we are happy we have fulfilled our promise to deliver the tape to the American People, they deserved it long ago. They know deserve accountability and to answer the fundamental question of who was the President the last four years.

The Oversight Project won't rest until this question is answered.

The Friday night and Saturday morning news dump of the tapes by Axios was by design. It was a controlled demolition to maximize profit for an upcoming book by one of their "journalists" but minimize the political damage to the Bidens and the Democrats. Likely that is why Axios spliced the tapes without notation in a manner that was easily detected.

This whole exercise is one of the ugliest things in the history of journalism. People who for years carried water for the Bidens and gaslit the American people about President Biden's obvious failing mental state are now set to make boatloads of money off the scandal they helped cover up.

The Oversight Project will always stand for the truth. We correctly called out how the Hur investigation was a limited hangout. We've unearthed the bombshell that the Biden White House was run via autopen. The autopenned pardons must be investigated. And we must know who was asserting Presidential authority without being the President.

Transparency and accountability are how our Nation will heal. There is no other path."

## **Background**

Special Counsel Robert Hur investigated President Biden for the mishandling of classified information. From the beginning we made clear to the American People that a comprehensive investigation required delving into the Biden Family burner phones and pseudonym email accounts. Obviously, such an investigation would have revealed the depths of the Biden Crime Family's corruption.



Hur's Report was deeply flawed because despite our warning he never obtained the relevant burner phone and pseudonym emails. Hur ultimately declined prosecution because he believed a jury would find President Biden to be a "well meaning elderly man with a poor memory." The Oversight Project filed multiple lawsuits to obtain additional records about the Hur investigation, including a lawsuit to compel the production of the audio recording of President Biden's interview with Special Counsel Hur.

The audio of the interview—which occurred in October 2023—shows clear indications of President Biden's mental decline at a time where the Biden Administration and their allies in the corporate media and government assured the American people he was fit for the job. Today's release further shows he was not.
